## **REGULATIONS FOR BURNING—PLEASE READ CAREFULLY**

1. All burning must be immediately extinguished upon the request of the Fire department, if complaints are received from citizens affected by the smoke or odor.
2. This permit is valid only at the location specified above, and only between the dates of: \_\_\_\_\_ and \_\_\_\_\_.
3. It is the responsibility of the permit holder to show a copy of this permit to police or fire personnel investigating complaints received from people complaining about smoke, and/or odor.
4. The permit holder must have the permission of the property owner at the location of the burning.
5. Burning authorized under this permit may be suspended by the Fire Chief due to weather or environmental conditions.
6. Burning is to be done only in the actual physical presence of a person 16 years or older. At no time is the fire to be unattended.
7. Contents of fires allowed under this permit shall be limited to landscape waste defined as: leaves, clippings, rakings, twigs, and branches, or brush no larger than two inches(2") in diameter.
8. Strictly prohibited from burning are: rubber, plastic, garbage, refuse, leather, building construction materials, petroleum products, any painted item, any flammable or combustible liquids, just to name a few.
9. All burning shall be at least fifty feet (50') from a building and NOT allowed in the public right-of-way.
10. The size of fires shall be limited to piles three feet (3') in height and eight feet (8') in diameter.
11. The permit holder shall take all reasonable actions to see that the fire does not spread.
12. No burning is allowed before sunrise. All fires must be extinguished on (1) hour before sunset.
13. The permit holder agrees that all damages caused to life and property by burning conducted under this permit is the total responsibility of the permit holder and further agrees to hold the City of Norway blameless for any such damages.
14. Failure to follow any of these rules listed above is a misdemeanor. The penalty for violating the conditions of this permit is a \$XX fine for the first (1<sup>st</sup>) offense, \$XXX fine for the second (2<sup>nd</sup>) offense, and a \$XXX fine for the third (3<sup>rd</sup>) offense.
